



2019-2020 Rules and Guidelines

In order to fulfill your Calf Scramble program requirements, you must complete the following:

1. SHOW REQUIREMENTS

- a) Enter your Calf Scramble project in the 2020 San Antonio Stock Show & Rodeo through your County 4-H or FFA Chapter by December 1, 2019. Individual Club and Chapter deadlines may be earlier. Please enter the Stock Show through the same 4-H Club or FFA Chapter that you entered the Calf Scramble. **Please note, as a calf scramble winner you are not automatically entered in the show.**
- b) Show your project at the 2020 San Antonio Stock Show & Rodeo. All projects purchased with the Calf Scramble Certificate MUST be shown. EX: If you purchased two gilts, you are required to show both gilts.

2. CALF SCRAMBLE MONTHLY REPORT SYSTEM REQUIREMENTS

- a) Complete the Calf Scramble Report System Monthly Reports for the following months: June, August, October, November, and January. The information requested on the reports are the minimum requirements of the Calf Scramble Report System.
- b) Utilize the format provided for each monthly report. A sample report can be found under the Calf Scramble Monthly Report System section of <http://www.sarodeo.com/livestock/calf-scramble-report-system>. Additional materials included in your reports are encouraged to add depth and quality. Items you may include are: photos, graphs, charts, etc.
- c) Calf Scramble Monthly Reports can be found under the Calf Scramble section of <http://www.sarodeo.com/livestock/calf-scramble-report-system>. Monthly Reports will be species specific and will cover various topics such as Animal Selection, Animal Care, Nutrition, etc. Check the Calf Scramble section of our website for further details.
- d) Each Report is due by the 20th of the respective month. The reports must be emailed to cscramble@sarodeo.com in PDF Format. The title for the email should state "Calf Scramble Report-Exhibitor Name-Month". Ex: Calf Scramble Report-John Smith-June. Each report submitted on or before the respective deadline for that month will be given 5 points added to the overall Final Report Book score. Each report submitted after the respective monthly deadline but on or before the next Monthly Report deadline will receive 2 points added to the Final Report Book score.

3. CALF SCRAMBLE FINAL REPORT BOOK REQUIREMENTS

- a) The Calf Scramble Report System will culminate with a Final Report Book due in the Livestock Office by January 20, 2020. Included in the Final Report Book will be the Monthly Reports already submitted (June, August, October, November) and bound together with the addition of the January Report.
- b) Final Report Book must not exceed 16" x 16" x 8" dimensions (LxWxH).

c) Additional items you may include are: photos, ribbons, and additional memorabilia you've collected while caring for and showing your project. Please place these items at the back of your Final Report Book. How you bind your book together is your choice and at your discretion. Have fun, be creative, and be imaginative.

d) Judging of the Final Report Book will be based on the following:

e) Results will be announced at the Calf Scramble Reception (date to be announced) where Final Report Books will be on display. Reports received in the Livestock Office after January 20, 2020 will not be judged or considered for competition.

IMPORTANT: If you do not fulfill these requirements, you will not receive the title to your project (Original Registration Papers), may be ineligible to compete with your Calf Scramble Project, and/or may be required to reimburse the San Antonio Livestock Exposition (S.A.L.E.) for the amount of the purchase certificate by March 31, 2020.
